2. Payments by you to us of the invoiced price of the goods or any other goods supplied by us (provided that in the case of payment by cheque, payment shall not be deemed to be made until the cheque is honoured).

Any re-sale of the goods by you or your customer, for which payment has not already been made to us, shall be effected to you as agent for us, to the intent that the proceeds of re-sale shall become our property upon receipt thereof by you, and so that the same shall thereupon be accounted for as to the extent of our wholesale invoiced price to you.

Until the property in the goods has been passed or been transferred from us to you, you shall hold and maintain the goods as bailee for us.

You, our customer hereby irrevocable grants to us, our agents and servants, an unrestricted right and licence, without notice, to enter the premises occupied by you to identify and remove any of the goods which are our property at our option without in any way being liable to you or any persons claiming through you. We shall have the right to sell or dispose of any such goods so removed or otherwise in our sole discretion and shall not be responsible for any loss occasioned thereby.

FORCE MAJEURE:

Matador Wholesale Pty Ltd shall be under no liability whatsoever in connection with or as a result of any loss caused by the failure of Matador Wholesale Pty Ltd to deliver goods by reason of whether wholly or in part, directly or indirectly, any Act of God, flood, fire, lightning, storm, tempest, rains, loss at sea, strikes, lock-outs or other industrial disturbances, riots, mechanical breakdown, non-delivery or shortage of materials, inability to obtain equipment or material, laws, rules or regulations of a governing body or any other reason whatsoever outside the control of Matador Wholesale Pty Ltd.
